Unless modified by the Chair at a particular meeting, due to circumstances on that occasion, each speaker is limited to three (3) minutes.

Commissioners may not discuss times that are not specifically identified on the agenda. Therefore, pursuant to A.R.S. 38-431.01(G), action taken as a result of public comment will be limited to directing staff to study the matter, responding to any criticism, or scheduling the matter for further consideration and discussion at a later date.

Personal attacks on Commission members, staff or other persons, in attendance or absent, are discouraged. Individuals are cautioned that statements concerning others that could be considered slanderous may subject the speaker to civil action.
